AUBURNDALE FIRE CHIEF BRIAN BRADWAY**

ISSUE: The City Manager will introduce the new Auburndale Fire Chief, Brian Bradway.

Brian Bradway began his public safety career with the Auburndale Fire Department as a firefighter in 2003. In 2010, he advanced in the profession as a driver engineer and Emergency Medical Technician with Polk County Fire Rescue. He was promoted to lieutenant in 2011 and worked out of the County's Loughman, Babson Park and Davenport stations. In May 2015, Bradway returned to the Auburndale Fire Department as Deputy Chief, a position designed to provide an opportunity for succession following the retirement of Chief Ronnie Hall. During his tenure as Deputy Chief, Bradway worked close with Chief Hall in advancing accreditation standards, software updates, developing the Department's first strategic plan, securing a \$377,000 Staffing for Adequate Fire and Emergency Response (SAFER) Grant, and last year played a lead role in the City's Hurricane Irma response.

Brian Bradway received his Fire Standards from Ridge Technical Center in April 2003 and holds an A.S. degree in Fire Science Technology from Polk State College graduating with the designation of Cum Laude in August 2017. He was selected in 2017 to participate in the Polk Vision – Leadership Polk Class XI and is a member of the Auburndale Rotary Club. He also serves as a mentor in the Auburndale Rotary – Florida Polytechnic University Mentorship Program.

In addition to providing outstanding fire and rescue services to our city residents and those in our service area, the Fire Department works so well with our various City departments and other agencies through mutual aid. The Auburndale Fire Department is a professional and exciting place to work. I am very optimistic about the direction, leadership and departmental experience that Brian brings to the position of Auburndale Fire Chief.

A reception for Chief Bradway and his family will be held immediately following his pinning held in the Fire Department Community Meeting Room.

The City Clerk will administer the Fire Chief's Oath of Office.
