The Auburndale Planning Commission will receive public input and make recommendations to the City Commission with respect to amending the Official Zoning Map.

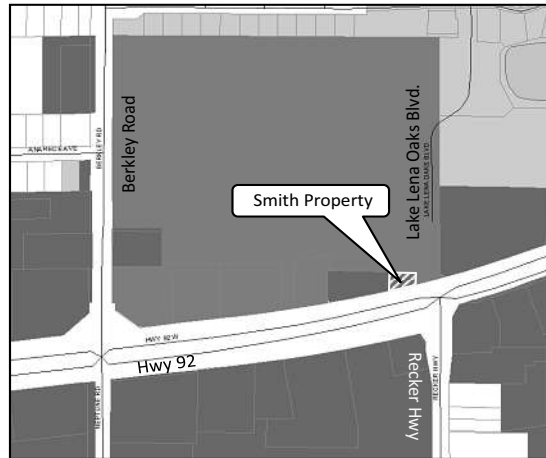
The proposed Land Development Regulations and Official Zoning Map Ordinance is entitled:

**AN ORDINANCE OF THE CITY OF AUBURNDALE, FLORIDA, AMENDING ORDINANCE NO. 764, THE LAND DEVELOPMENT REGULATIONS OF THE CITY OF AUBURNDALE, FLORIDA, BY AN AMENDMENT TO THE ZONING MAP RECLASSIFYING A PARCEL OF LAND TOTALING +/- 0.15 ACRES FROM CITY OF AUBURNDALE ZONING CLASSIFICATION PLANNED DEVELOPMENT-COMMERCIAL 1 (PD-C1) TO COMMERCIAL HIGHWAY (CH); AND PROVIDING AN EFFECTIVE DATE. (General Locations: US Hwy. 92 W, and Recker Hwy.).**

**Amend the Zoning Map as follows:**

**Smith Property:** Reclassify from City of Auburndale Zoning Planned Development-Commercial 1 (PD-C1) to Commercial Highway (CH).

Area: +/- 0.15 acres
