The Auburndale Planning Commission will receive public input and make recommendations to the City Commission with respect to amending the Official Zoning Map.

Notice is hereby given that the City Commission of the City of Auburndale, Florida, will hold a Public Hearing on Monday, July 16, 2018 at 7:00 p.m., in the City Commission Room, City Hall, to hear and consider the first reading of a proposed Ordinance amending No. 764, the City's Land Development Regulations and Official Zoning Map.

The proposed Land Development Regulations and Official Zoning Map Ordinance is entitled:

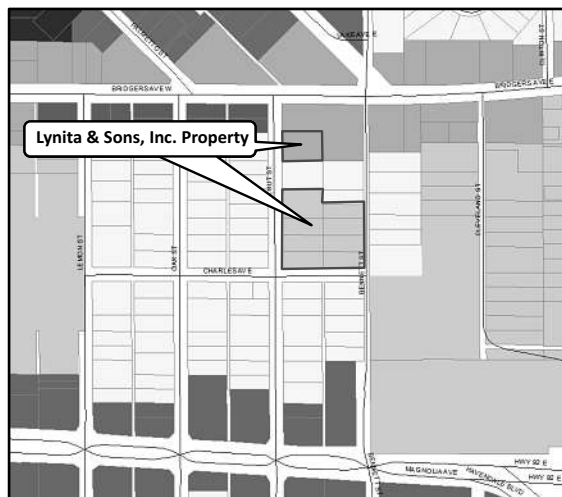
AN ORDINANCE OF THE CITY OF AUBURNDALE, FLORIDA, AMENDING ORDINANCE NO. 764, THE LAND DEVELOPMENT REGULATIONS OF THE CITY OF AUBURNDALE, FLORIDA, BY AN AMENDMENT TO THE ZONING MAP RECLASSIFYING PARCELS OF LAND TOTALING +/- 2.07 ACRES FROM CITY OF AUBURNDALE ZONING CLASSIFICATION GENERAL COMMERCIAL (CG) AND GENERAL RESIDENTIAL-1 (RG-1) TO SINGLE FAMILY RESIDENTIAL-3 (RS-3); AND PROVIDING AN EFFECTIVE DATE. (General Locations: Bridgers Ave. E. and Bennett).

Amend the Zoning Map as follows:

Lynita and Sons, Inc. Property: Reclassify from City of Auburndale Zoning classification of Commercial General and General Residential-1 to Single Family Residential-3 (RS-3).

Property Description: Auburndale Heights Subdivision, Block 1, lots 19 & 20 and lots 8 through 16

Area: +/- 2.07 acres



The proposed Ordinance is available for review in the Planner's Office, City Hall, One Bobby Green Plaza, Florida, weekdays from 8:00 a.m. to 5:00 p.m. Interested parties may examine the Ordinance and Map there or appear at the meeting and be heard with respect to such proposed amendments.

At said hearing any person, his Agent or Attorney, may appear and be heard. If a person decides to appeal any decision made by the City Commission with respect to any matter considered at such hearing, they will need a report of the proceedings, and that, for such purposes, they may need to ensure that a verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is based (FS.286.0105).
