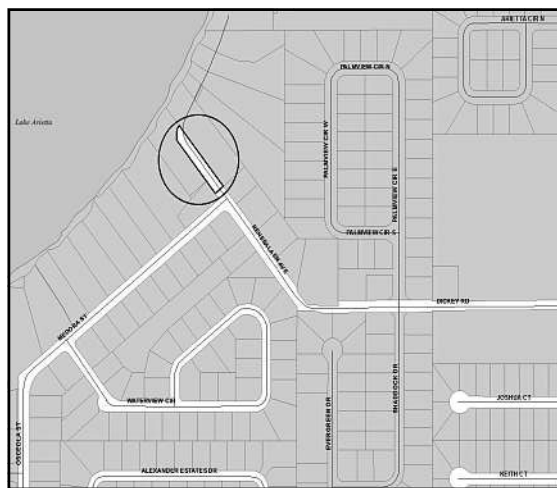
Notice is hereby given that the City Commission of the City of Auburndale, Florida, will hold a **Public Hearing** on Monday, July 2, 2018, at 7:00 p.m., in the City Commission Room, City Hall, to hear and consider the adoption of a Resolution vacating, abandoning and discontinuing a public Right-of-Way.

The proposed Resolution is entitled:

A RESOLUTION VACATING, ABANDONING AND DISCONTINUING A PORTION OF A PUBLIC RIGHT-OF-WAY KNOWN AS RENNSALAER AVENUE; AND PROVIDING AN EFFECTIVE DATE (General Location: Renssalaer Avenue, lying north of Medora Street.)

DESCRIPTION:

A portion of Renssalaer Avenue lying north of Medora Street, being part of the Replat of Arietta Shores Subdivision, Auburndale, FL, according to map or plat thereof recorded in Plat Book 31, Page 1, Public Records of Polk County, Florida.



The proposed Resolution is available for review in the Community Development Office, One Bobby Green Plaza, Auburndale, Florida, weekdays from 8:00 a.m. to 5:00 p.m. Interested parties may examine the Resolution and Map there or appear at the meeting and be heard with respect to such proposed amendment.

At said hearing any person, his Agent or Attorney, may appear and be heard. If a person decides to appeal any decision made by the City Commission with respect to any matter considered at such hearing, they will need a report of the proceedings, and that, for such purposes, they may need to ensure that a verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is based (FS. 286.0105).
