ORDINANCE NO. 1572

AN ORDINANCE OF THE CITY OF AUBURNDALE, FLORIDA, ESTABLISHING THE TAX LEVY FOR THE YEAR 2018 ON ALL PROPERTY WITHIN THE CORPORATE LIMITS OF THE CITY OF AUBURNDALE AS SHOWN BY THE 2018 ASSESSMENT ROLL; ESTABLISHING THE MILLAGE RATE AT 4.2515, WHICH IS EQUAL TO THE ROLLED BACK RATE OF 4.2515, AND PROVIDING FOR THE APPLICATION THEREOF; AND PROVIDING AN EFFECTIVE DATE.

AN ORDINANCE OF THE CITY OF AUBURNDALE, FLORIDA, ADOPTING THE FISCAL YEAR 2018-2019 ANNUAL BUDGET; CONCEPTUALLY APPROVING THE FISCAL YEAR 2019-2020 ANNUAL BUDGET; ADOPTING THE FIVE (5) YEAR SCHEDULE OF CAPITAL IMPROVEMENTS (CIP); AND PROVIDING FOR AN EFFECTIVE DATE.

ORDINANCE NO. 1574

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF AUBURNDALE, FLORIDA, SO AS TO INCLUDE THEREIN ADDITIONAL TERRITORY LYING CONTIGUOUS AND ADJACENT TO THE PRESENT BOUNDARIES OF THE CITY; DESCRIBING SAID ADDITIONAL TERRITORY; REPEALING ALL ORDINANCES IN CONFLICT HEREWITH; AND PROVIDING AN EFFECTIVE DATE (General Location: Berkley Road and Pearce Road).
