**AN ORDINANCE OF THE CITY OF AUBURNDALE, FLORIDA, AMENDING ORDINANCE NO. 764, THE LAND DEVELOPMENT REGULATIONS OF THE CITY OF AUBURNDALE, FLORIDA, BY AN AMENDMENT TO THE OFFICIAL ZONING MAP ESTABLISHING A CITY OF AUBURNDALE ZONING MAP CLASSIFICATION OF PLANNED DEVELOPMENT - HOUSING 2 (PD-H2) AND ON A PARCEL OF LAND TOTALING +/- 19.52 ACRES; AND PROVIDING AN EFFECTIVE DATE (General Location: Pearce Road).**
