**AN ORDINANCE OF THE CITY OF AUBURNDALE, FLORIDA, ESTABLISHING THE TAX LEVY FOR THE YEAR 2019 ON ALL PROPERTY WITHIN THE CORPORATE LIMITS OF THE CITY OF AUBURNDALE AS SHOWN BY THE 2019 ASSESSMENT ROLL; ESTABLISHING THE MILLAGE RATE AT 4.2515, WHICH IS A 4.8% INCREASE OVER THE ROLLED BACK RATE OF 4.0566, AND PROVIDING FOR THE APPLICATION THEREOF; AND PROVIDING AN EFFECTIVE DATE .**

**ORDINANCE NO. 1620**

**AN ORDINANCE OF THE CITY OF AUBURNDALE, FLORIDA, AMENDING ORDINANCE NO. 764, THE LAND DEVELOPMENT REGULATIONS OF THE CITY OF AUBURNDALE, FLORIDA, BY AN AMENDMENT TO THE OFFICIAL ZONING MAP BY ESTABLISHING A CITY OF AUBURNDALE ZONING MAP CLASSIFICATION OF PLANNED DEVELOPMENT-HOUSING 2 (PD-H2) ON A PARCEL OF LAND TOTALING +/- 20.11 ACRES; AND PROVIDING AN EFFECTIVE DATE (General Location: Pearce Road).**
