The City of Auburndale will receive sealed bids for the renovations of the Municipal Services Building, previously the SunTrust Bank Branch at 6 Bobby Green Plaza, Auburndale, until Friday, December 15, 2023, at 2:00pm EST.

One (1) original submittal of the proposal must be addressed to the Finance Director and mailed to Post Office Box 186, Auburndale Florida, 33823, or delivered to the City Manager's Office, City Hall, One Bobby Green Plaza, Auburndale, Florida, 33823, on or before the above specified date and time. Each bid must be submitted in a sealed envelope and addressed to the Finance Director, City of Auburndale, and plainly marked in the lower left corner of the envelope "Sealed Bid – Proposal for the City of Auburndale's Municipal Services Building Renovations – Flooring"

Proposers are also required to include a completed Non-collusion Affidavit of Prime Bidder Form and PUR 7068 Form with the sealed bid.

The City reserves the right to reject any or all bids, to waive informalities, to re-advertise, and to accept the bid that is in the best interest of the City, which may not necessarily be the lowest bid. Reasonable variations from bid specifications will be considered.

BID SPECIFICATIONS

1. A mandatory pre-bid conference will be held on Thursday, November 16 at 6 Bobby Green Plaza, Auburndale at 3:00pm EST.
2. The successful bidder will be required to provide the necessary Flooring services that are specified in the construction plans which are available on the City's website at <http://www.auburndalefl.com/rfps/>.
3. The successful contractor shall maintain all necessary insurance coverage's as required by local, state and federal law during the term of the project including:
 - a. Workers Compensation Insurance, as required by state law, for all employees engaged in work under this contract.
 - b. Property Damage, Automotive and General Liability Insurance of not less than \$1,000,000 on account of all accidents.
4. The successful contractor shall furnish proof of insurance prior to the commencement of the project.
5. The successful contractor shall be licensed as a Certified or Registered Contractor with the State of Florida and should maintain all necessary City and County permits and licenses.
6. All Flooring installations must be performed in accordance with local, state and federal, building and fire safety codes and regulations.
7. The proposed bid should include all costs associated with this Invitation to Bid.

The term "affiliate" includes those officers, directors, executives, partners, shareholders, employees, members, and agents who are active in the management of an affiliate. The ownership by one person of shares constituting a controlling interest in another person, or a pooling of equipment or income among persons when not for fair market value under an arm's length agreement, shall be a prima facie case that one person controls another person.
